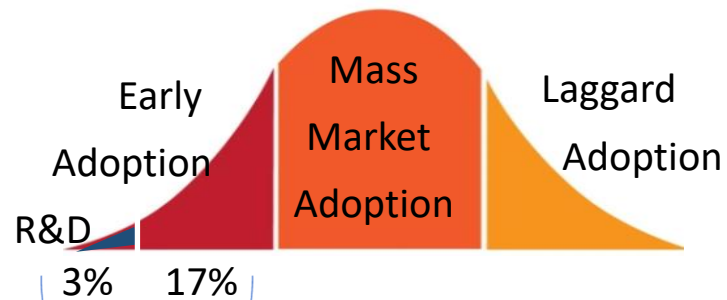
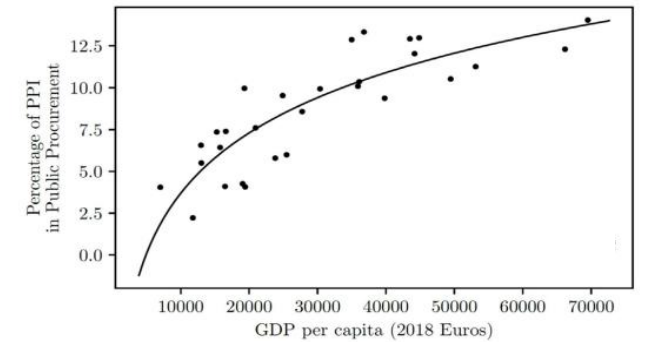
# Strategic importance of innovation procurement



Many societal challenges unsolvable via public procurement of 'existing' solutions. Public procurement of R&D / innovative solutions needed.



Studies: Innovation procurement essential for economic growth. Direct relation between innovation procurement investments and growth of GDP per capita.



Healthy economies worldwide spend minimum: 20% of public procurement on innovation procurement. EU average is ~10%. ([EU wide Benchmarking](#))



**ICT**  
is key catalyzer

Healthy economies worldwide spend minimum: 10% of public proc (or 60% of innov proc) on 'ICT-enabled' solutions. EU average is ~3,5% of public proc (or ~40% of innov proc)

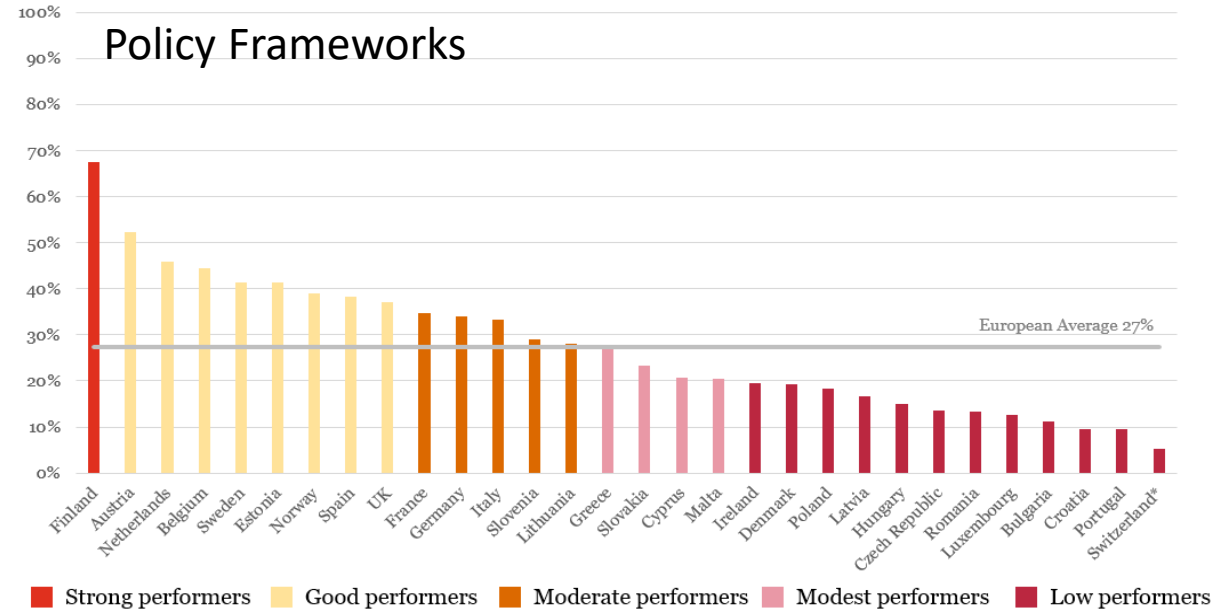

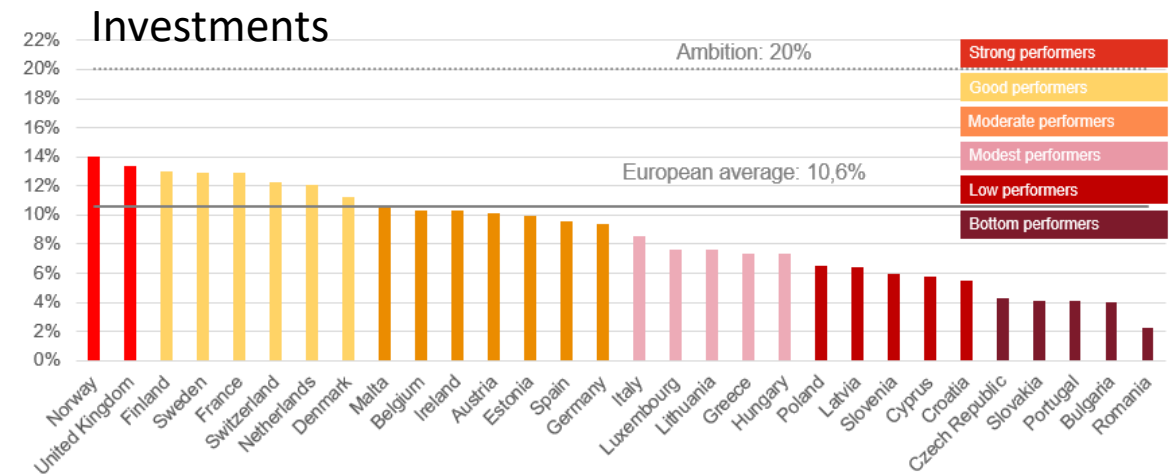

# Impacts achieved EU funded PCPs

- **Boosting business opportunities for SMEs and startups**

- Awards 70% instead of usual 30% of contracts to SMEs and startups
- Boosts their international growth (20 X more contracts awarded cross-border)
- Doubles commercialisation success rate (>50% companies increased their revenues/grew their company)
- Helps create strategic partnership with larger companies, acquire new companies or enter the stock market
- Helps startups/SMEs obtain financial investments > 4 times the amount invested in the pre-commercial procurements

- **More efficient, higher quality solutions** solving real-life problems

- 20%-30% of quality and efficiency improvements in public services.
- Startups/SMEs really changed the life of citizens, public administrations and other businesses with their innovations
- Contributes to roll-out of **more interoperable solutions** / uptake of **standards**
  - 40% of innovation procurements are done to obtain more interoperable solutions

- **Reinforces strategic autonomy** through 'made in Europe' solutions

- Procurements of R&D and deployment of first batch of tested solutions can be limited to EU (controlled) companies and require large part of R&D and later commercialisation to take place in EU -> new EU lead markets

# Example: Robotics for healthcare / public buildings

Nationally funded PCP  
Danish regions / hospitals  
EU helped with PPI



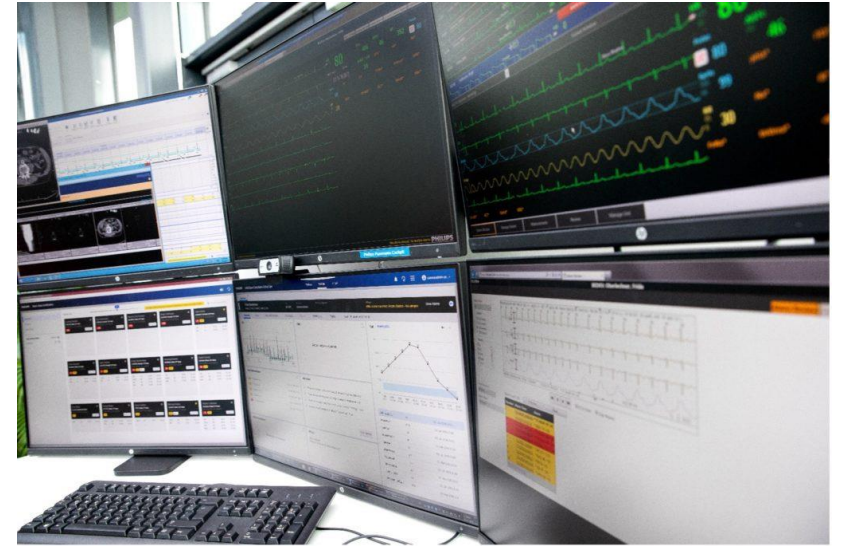
- [2014-2016: PCP by Danish hospitals](#)  
Result: Blue Ocean Robotics (Danish startup) created innovative disinfection robots that kill 99% of all viruses & bacteria within 10 minutes.
- [2020: EU bought 300 of these 'EU made' robots for hospitals around Europe to fight COVID.](#)  
Largest order so far for the company, triggered wider diffusion of the solutions, selling worldwide. Steep growth, VC funding, becoming a unicorn. Strengthens European position in robotics.

# Example: AI for healthcare

**Thalea**)))

EU funded PCP & PPI  
University hospitals



Highly interoperable telemedicine platform for tele-detection and tele-care of ICU-patients at increased risk.

**Procurers:** University Clinic Aachen (DE), University Hospital Maastricht (NL), Parc Tauli Sabadell University Hospital (ES), Hospital East Limburg (BE), Northern Ostrobothnia Hospital District (FI)

**Results:** In between PCP and PPI certification took place, buyers group was enlarged. Solutions now deployed.

- Tele-detection and tele-care Cockpit with big data analysis, self learning and predictive capabilities
- Earlier diagnosis and improve efficiency in intensive care
- 25% lower sepsis mortality and 20-50% shorter hospital stay
- ERDF funding allowed to test / demonstrate solution in more EU countries -> new deployments
- Commercialised globally (sold/installed in +30 hospitals worldwide)

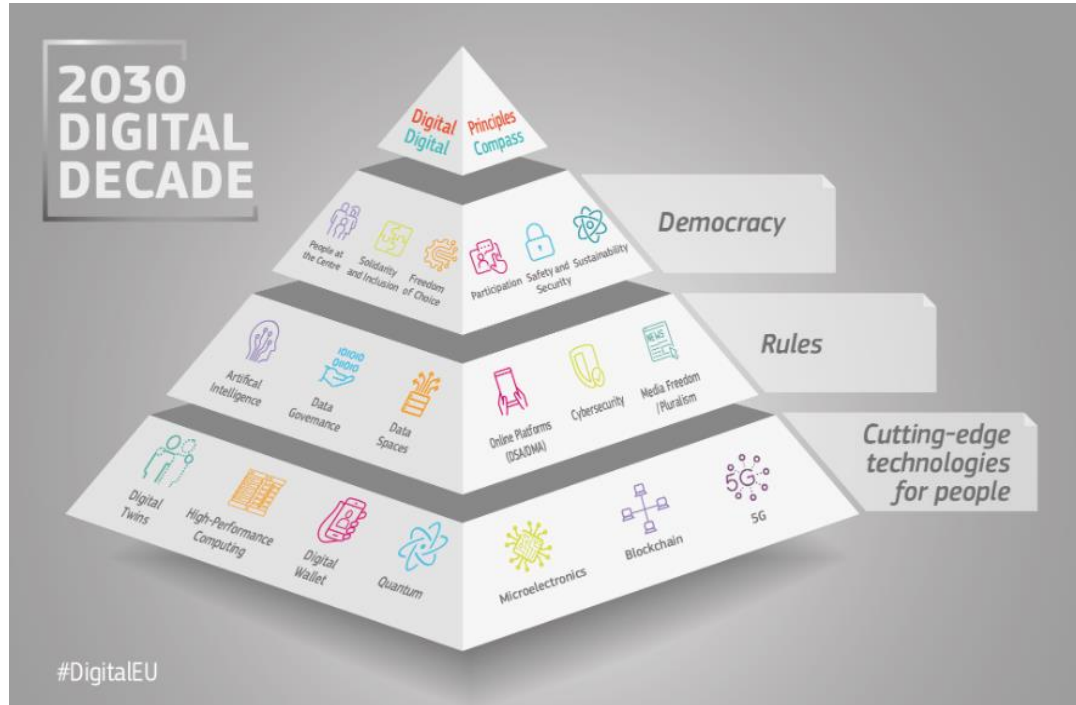

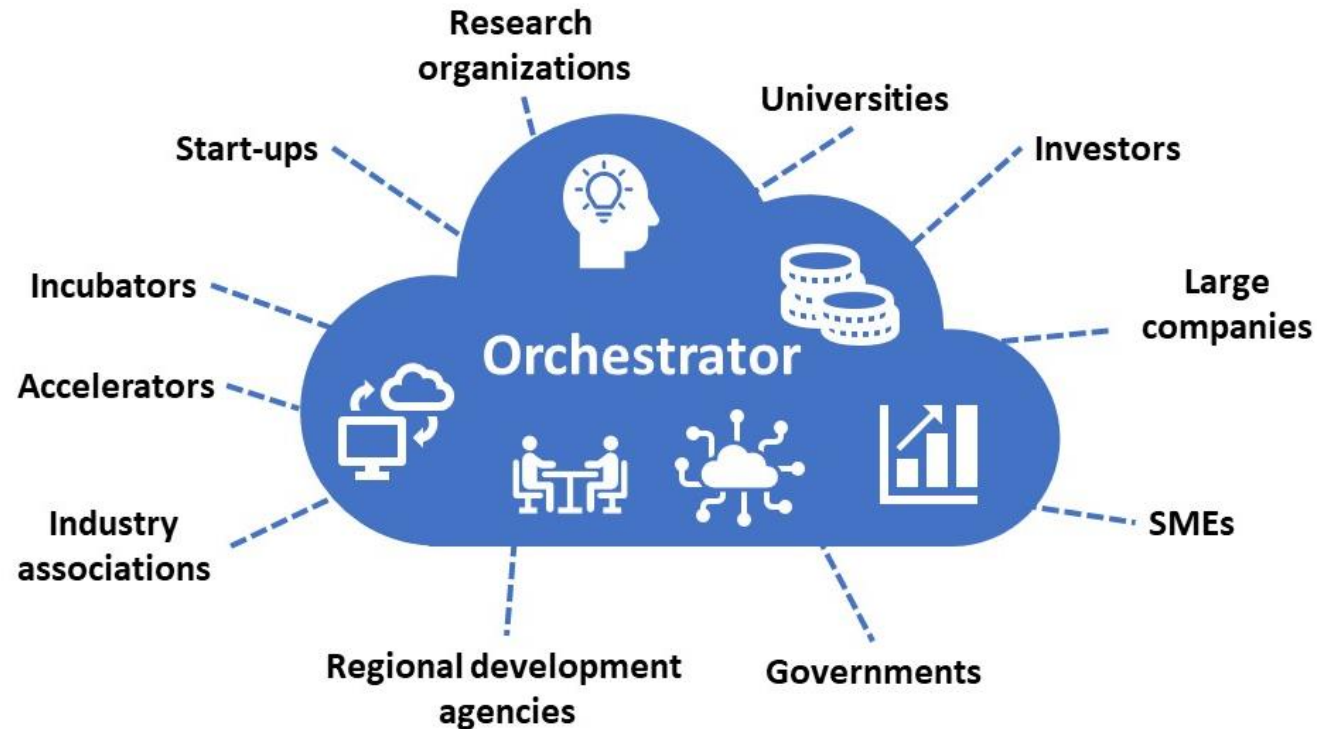

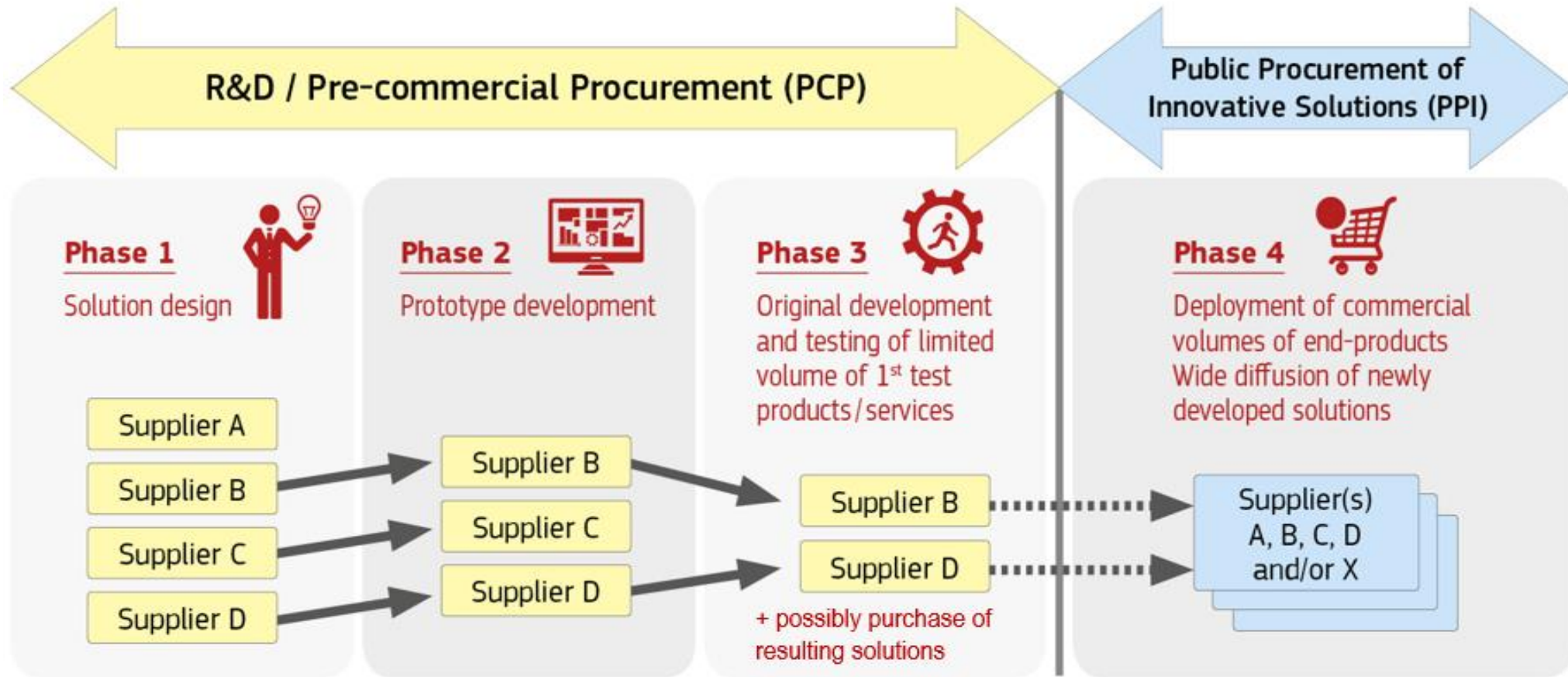

# Innovation Procurement



PCP falls outside WTO GPA and EU public procurement directives ([COM\(2007\)799 & SEC\(2007\)1668](#))

[More than 600 public buyers around Europe](#) have already successfully implemented PCPs

PPI uses procurement procedures defined in EU public procurement directives and national law

# Split between PCP and PPI enables to



Use PPI also if no R&D needed for procurement need

Get 20% better value for money products (US defense data)



Use a small budget PCP to de-risk a large budget PPI

- PPI spec can be 'completely rephrased', benefiting from PCP lessons learnt



Use conditions to create strategic autonomy & growth/jobs 'in Europe'

- Because PCP falls outside WTO rules



Prevent foreclosing competition & crowding out other R&D investments

- Companies that are not financing their R&D via the PCP (e.g. via grants, own internal company resources, other investors, other procurements) can still bid for deployment contracts/PPIs



Facilitates access to procurement market for SMEs

- Gradually increasing contract sizes, tasks, required manpower
- Stringent financial guarantee/qualification requirements: 'no' in PCP, 'ltd' in PPI

... All the above is not the case if R&D is procured as part of/inside large deployment contract

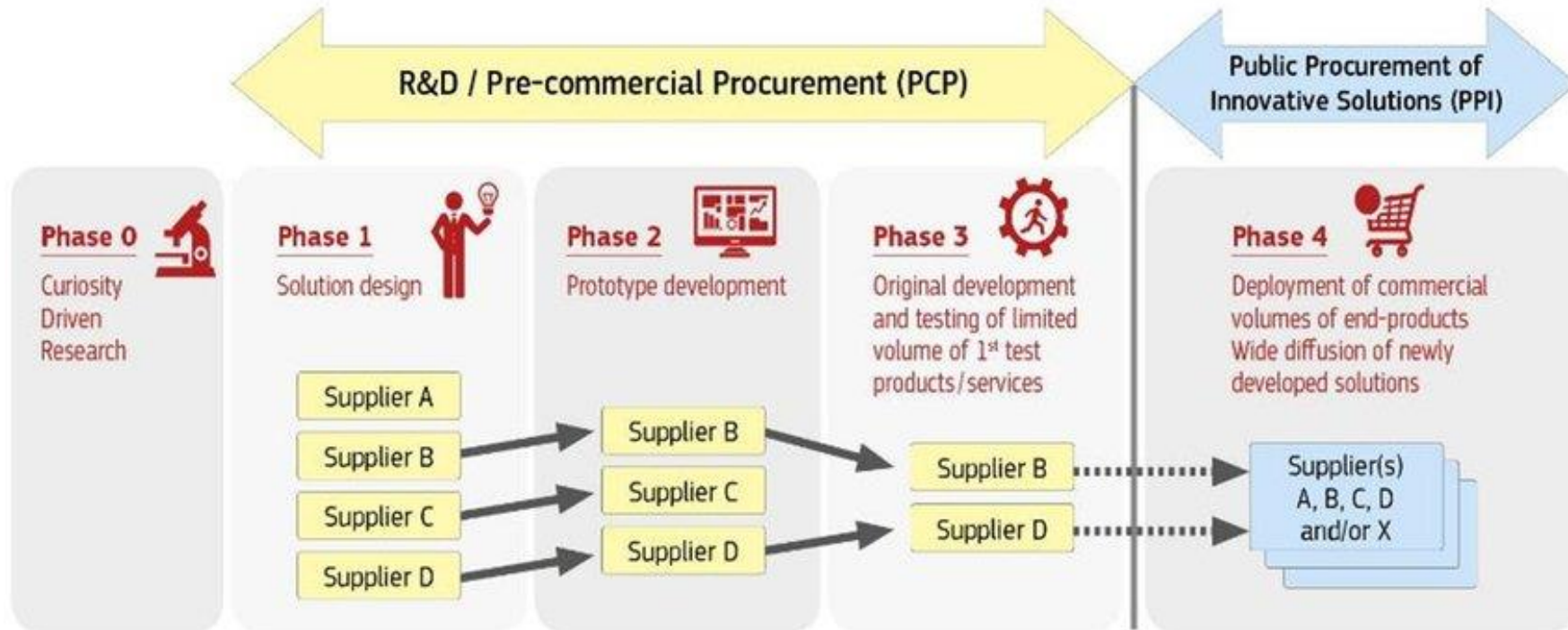

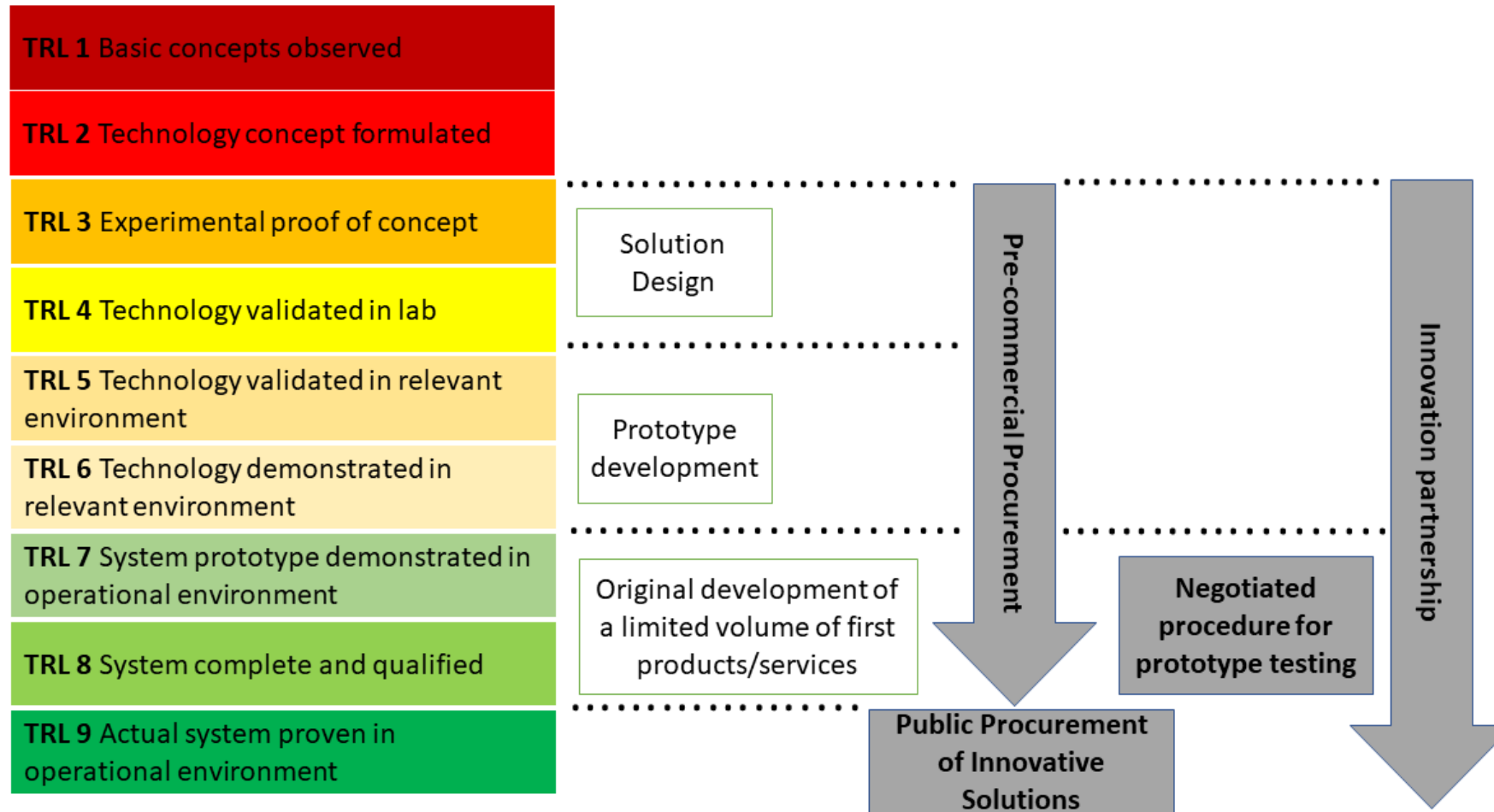
# Innovation Procurement

*Innovation Procurement happens when **public buyers** acquire the **development or deployment of pioneering innovative solutions** to address specific mid-to-long term public sector needs.*

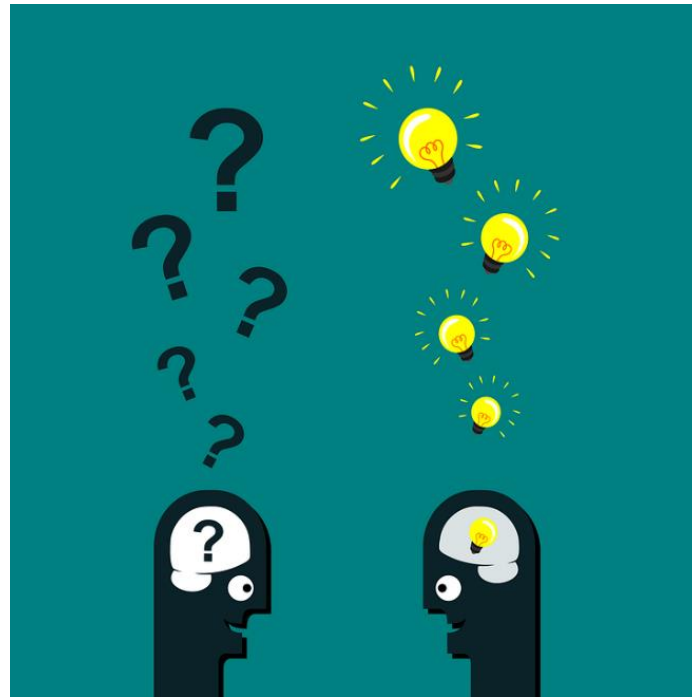

# Technology Readiness Level (TRL)

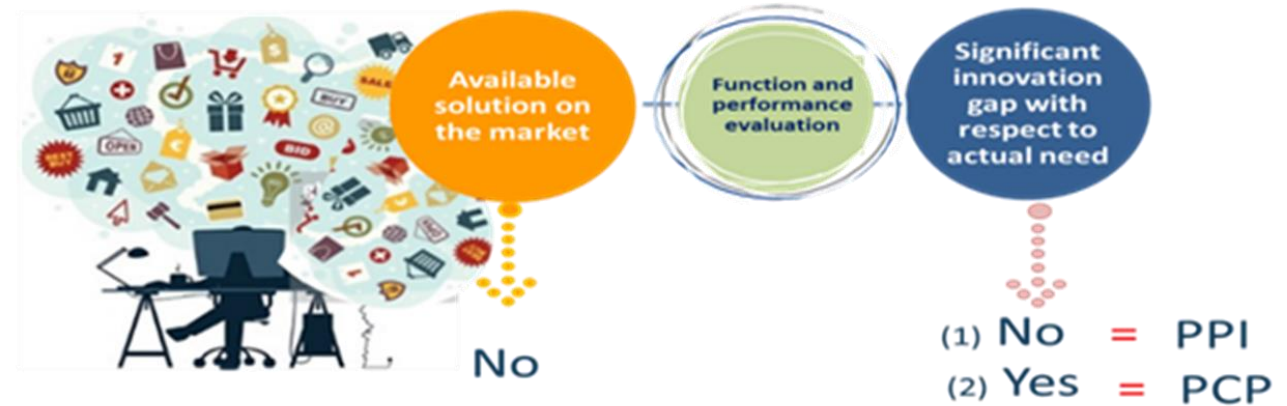


# Pre-Commercial Procurement (PCP)



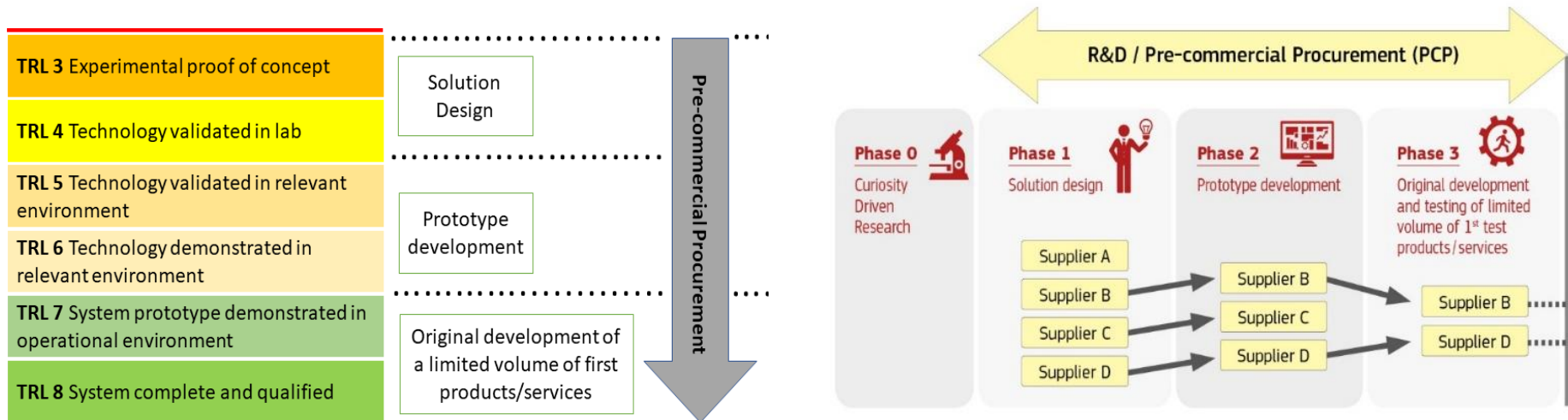
# PCP approach

- **R&D is needed to identify an innovative solution** to satisfy public procurers' needs.
- **No solutions exist yet on the market** that meet public procurers' needs and based on a search conducted by the procurers, it does not seem that such a solution will be available on a short-term notice.



- (1) Improvements are needed but don't require new and significant R&D (only integration, incremental adaptations and improvement, customization...), so authority can act as early adopter of innovative commercial end-solutions newly arriving on the market
- (2) There isn't any solution or the problem is so technologically demanding that a radical and breakthrough new solution and significant R&D is needed.

# PCP approach



**PCP** is a public procurement of Research and Development (**R&D**) **services** characterized by:

- ✓ **competitive** development in **phases**
- ✓ **risk-benefit sharing** under market conditions → Public procurer does not pay the full cost of the R&D performed under the contract
- ✓ a clear **separation** between the procurement of the R&D from the deployment of **commercial volumes of end-products**

# Legal Framework for PCP

- **PCP falls outside the scope of the European Public Procurement Directives**

Article 14 D. 2014/24/EU, Article 32 D. 2014/25/EU and Article 25 D. 2014/23/EU

“this Directive shall only apply to public service contracts for research and development services [...] provided that both of the following conditions are fulfilled: (i) the benefits accrue exclusively to the contracting authority for its use in the conduct of its own affairs, and (ii) the service provided is wholly remunerated by the contracting authority”.

- The **general principles of the TFEU** are applicable

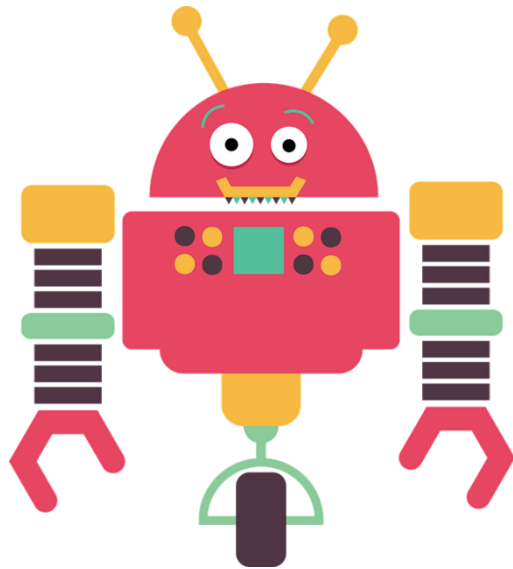

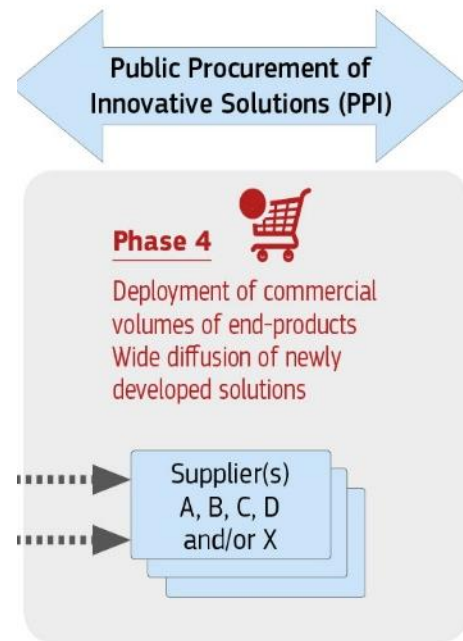


# Public Procurement of Innovative Solutions (PPI)



# PPI approach

- Purchase of **innovative solutions** which are **not yet available on a large-scale** commercial basis.



PPI is characterized by:

- ✓ It does not include R&D (it has already been conducted or it is not needed).
- ✓ The contracting authority act as a **launching customer** of innovative goods or services to trigger a market response.
- ✓ It may include conformance testing.
- ✓ It falls within the scope of the European Public Procurement Directives.

# Legal Framework for PPI

- **PPI falls within the scope of the European Public Procurement Directives**

Use the procurement procedures contemplated in the Directives (Article 26 of D.2014/24/EU and similarly Article 44 D.2014/25/EU)

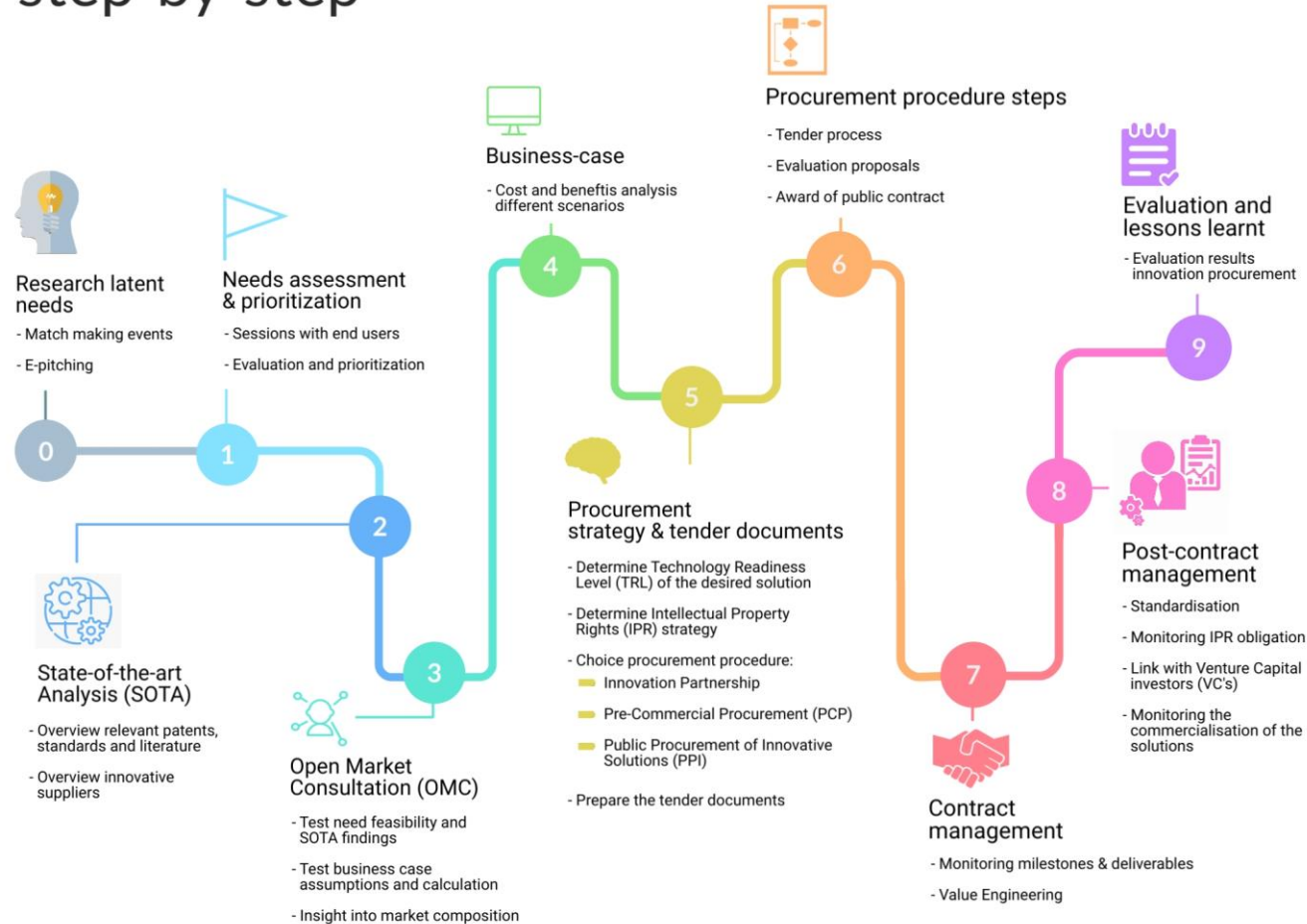
“When awarding public contracts, contracting authorities shall apply the national procedures adjusted to be in conformity with this Directive”

- The **general principles of the TFEU** are applicable

# EAFIP scope of assistance

EAFIP provides local assistance to selected public procurers in the preparation and implementation of a PCP or PPI procurement, covering:

- Scoping an identified procurement need that can be tackled with innovative solutions
- Preparing and conducting an EU wide published open market consultation
- Drafting tendering documents
- Launching an EU wide published call for tender
- Answering questions from potential tenderers at any time during the process
- Signature of contracts with selected vendor(s), taking into account the relevant provisions under European and national legislation governing public procurement.



## **SELECTION CRITERIA:**

1. Concrete interest / commitment in starting a PCP/PPI project and maturity of the business case
2. Potential impact of the PCP/PPI
3. Geographical balance of the cases to be assisted across the EU member states.
4. Lack of experience and existence of prior cases in the implementation of PCP/PPI under the legal system of the country in question



# EAFIP type of assistance

Assistance includes one-to-one meetings, support by email, hands-on guidance and individual support (including legal support) to prepare and implement a PCP or a PPI procurement.

The assistance provided within the EAFIP-initiative does not consist of financial support for activities carried out by the procurer.

Each selected project benefits from a total of 5 person-days expert assistance free of charge. Local assistance is provided in the local language of the procurer through the EAFIP Network of Experts established across all the EU Member States under the coordination of Corvers. 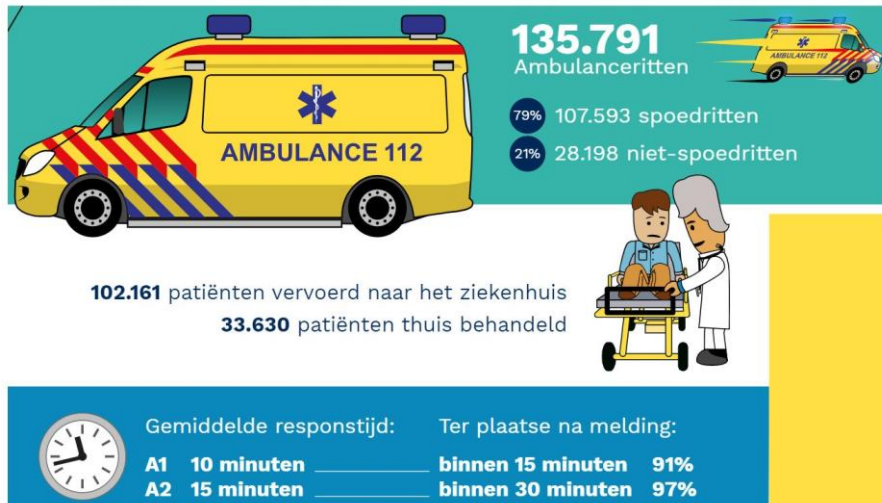


## WBL WINS EUROPEAN INNOVATION PROCUREMENT AWARD 2021



- On the 25th of November 2021 Waterschapsbedrijf Limburg (WBL) won the first prize at the [European Innovation Procurement Awards \(EUIPA\)](#) 2021 in the ‘Facing societal challenges’ category for its integrated PCP & PPI project.
- The [Waterschapsbedrijf Limburg \(WBL\)](#) – Dutch wastewater treatment company – launched a full-blown procurement project. The project, which tackles both innovation and circularity, combined three different lots (process automation, security and big data) with a PCP (that builds on and supports the three lots). The PCP results are integrated as part of the big data PPI to support process automation and security. The purchased solution will improve management of wastewater transportation pipelines by allowing WBL to continuously monitor their correct functioning and proactively tackle issues.

# RAV Brabant MWN Navigation and Information System for ambulances in the Netherlands



End-to-end solution, easy to replace in case of breakdown, with increased location precision, immediate response time and less margin of error.

**Public Procurement of Innovative Solutions (PPI)**

Based on a map/application that already includes considerable amounts of geolocation information and Points of Interest but should also allow RAV Brabant MWN to include new information.

**Use of Galileo Public Regulated Service (PRS) channels .**

The information that has to be shared to provide for a better health service has to be protected/encrypted because it is sensitive information.

**RAV Brabant MWN working with VZVZ** to ensure the deployed solution is compliant with high personal data and security standards.

# 4. Conclusions

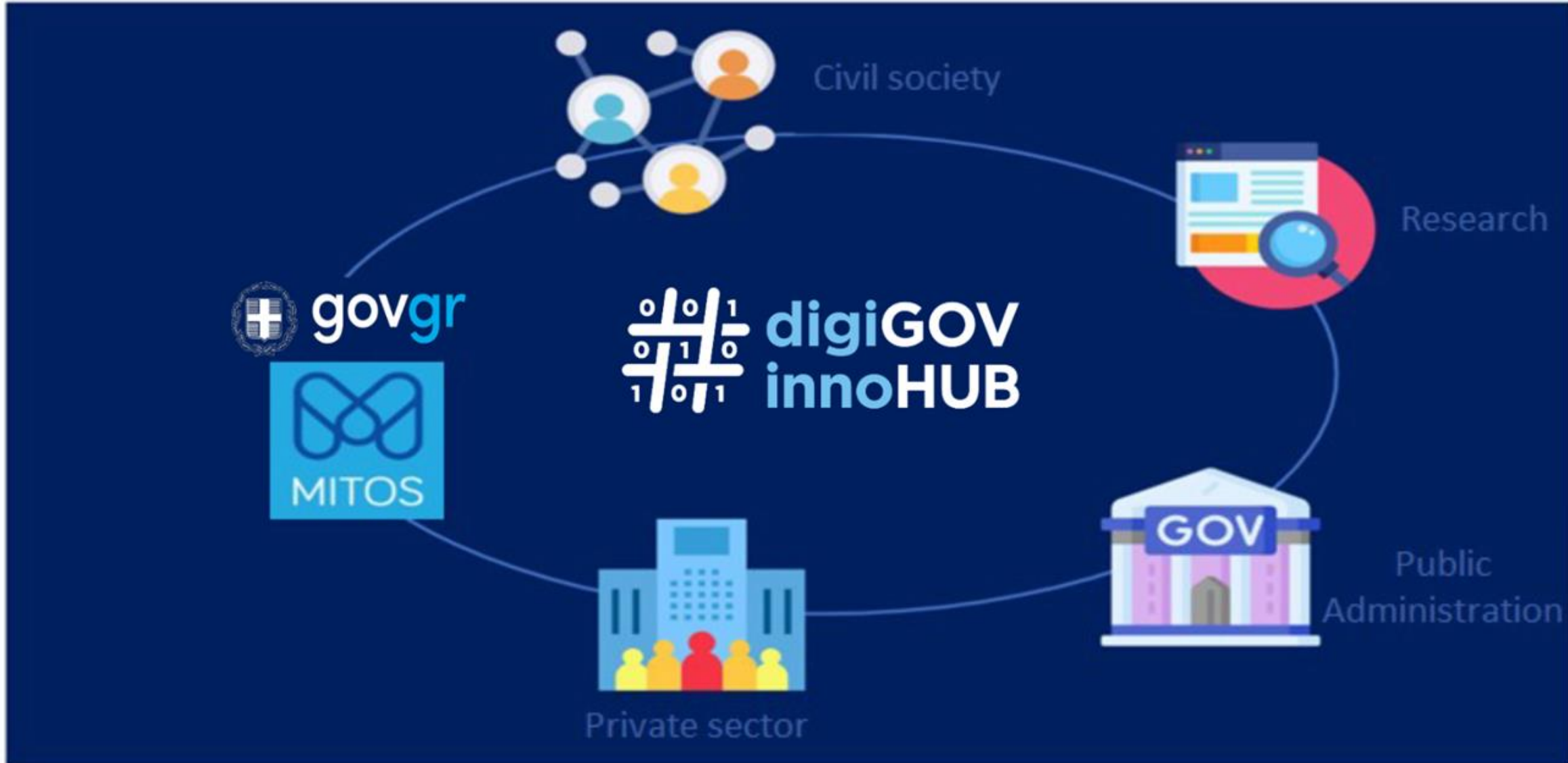

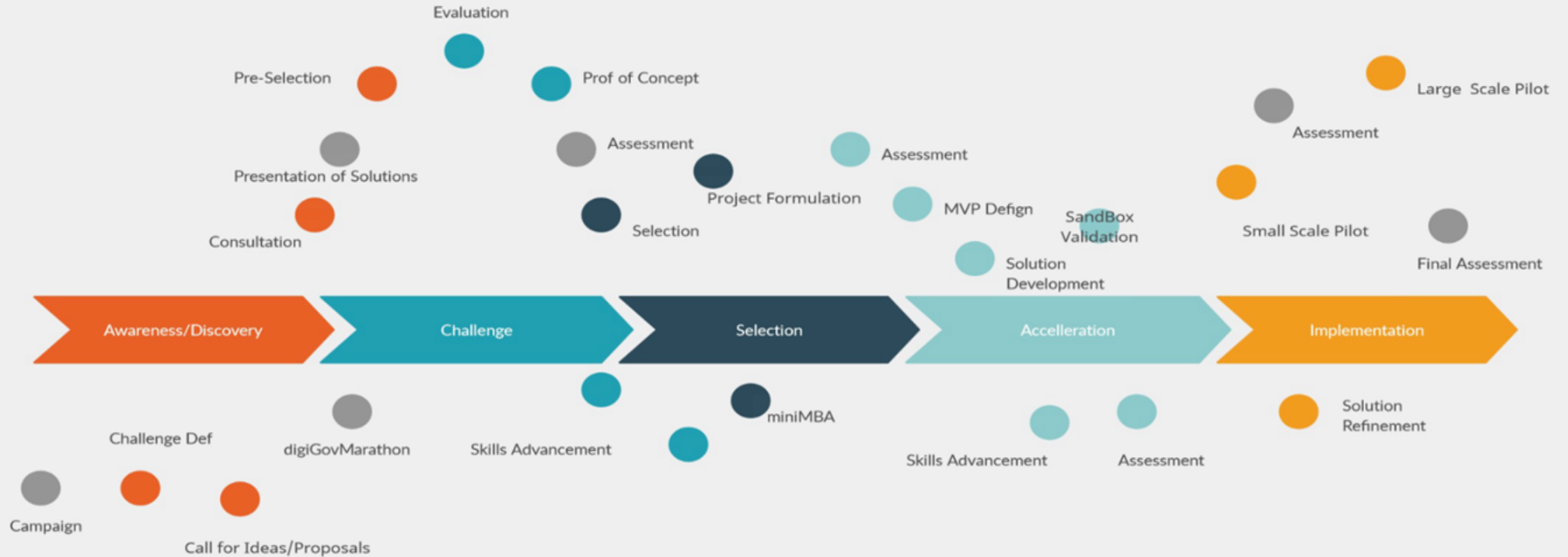

# Challenges elicitation with PSOs

Awareness Campaign and Consultation meetings with PS organisations active in Digital Transformation (central and regional government).

# Challenges selection – matrix evaluation

## A. Horizontal Criteria for prioritising challenges (pre-selection)

1. The challenge **is** in line with the Greek Digital Transformation Strategy;
2. Solving the problem has the potential to **create significant impact**, e.g., the solution can be reused by other organisations, and/or will have a significant impact on the user/citizen experience
3. There is a challenge owner to support the challenge from its definition, solution implementation and deployment.

## B. Vertical Criteria for challenges selection

1. Necessity - the solution responds to important needs of public organisations
2. Feasibility - the solution is technologically and organisationally feasible & expertise is available

## C. Public Consultation for 2 weeks / comments and voting by all Hub participants

## D. Final selection of 4 challenges by Special Committee

# Multi lingual access to GOV.gr services

**Objective:** Automated **translation mechanism for digital public services** on Gov.gr to ensure equal access for foreign language users.

**Context:** Greece's multicultural landscape with a substantial number of tourists, immigrants, refugees, and remote workers.

## Requirements:

- Adaptability: Solution able to cater to dynamic and ever-changing service catalogues.
- Integration: Easy integration into the existing infrastructure
- Accessibility: Compliance with the EU's accessibility guidelines.
- Flexibility: Solution should function optimally on the Gov.gr portal and be usable by other digital service providers.

**Unique Challenge:** Addressing the specialized vocabulary used by the Greek public administration. The solution must have the capacity to be trained & refined to enhance its accuracy.

# Streamlining Multifaceted Administrative Procedures with AI

**Objective:** Deliver personalized **benefits** related **services**, making them as intuitive and frictionless as possible for citizens.

**Context:** The Greek Public Administration is facing a challenge in promptly and efficiently addressing increasing volumes of citizens' queries about various benefits and services.

**Issue:** Finding relevant information on public websites can be burdensome, particularly for citizens less familiar with digital world.

## **Requirements:**

- User-friendly: Intuitive and easy to use for all citizens, regardless of their digital proficiency.
- Scalability: Capable of handling high volumes of queries and requests efficiently.
- Security & Privacy: Must adhere to data protection regulations and ensure the security and privacy of user data.
- Interoperability: Should be able to integrate smoothly with existing public administration systems and databases.



# AI Improves Efficiency in the Justice System



**Objective:** AI solutions to help **analyze large volumes of textual data:** such case files, legal documents, witness statements, and court decisions.

**Context:** The slow delivery of judicial services in Greece due to the overwhelming volume and complexity of case-related information.

**Issue:** The enormity of the information, its complexity, and the absence of effective ICT tools for analysis and comprehension leads to increased workloads, delays, human errors, & decline in service quality.

## Requirements:

- **Efficiency:** significantly reduce time and effort required in processing large volumes of case-related data.
- **Accuracy:** minimize human error and enhance the precision of information processing and analysis.
- **Usability:** easy to use and integrate into the existing judicial workflows.
- **Security & Privacy:** Must adhere to data protection regulations and ensure the security and privacy of sensitive case-related information.

# AI Voice Command System for Accessible Public Administration Websites

**Objective:** Create a robust **voice command system** that enhances accessibility of public websites **for citizens with disabilities**, thereby achieving AAA compliance with W3C accessibility guidelines.

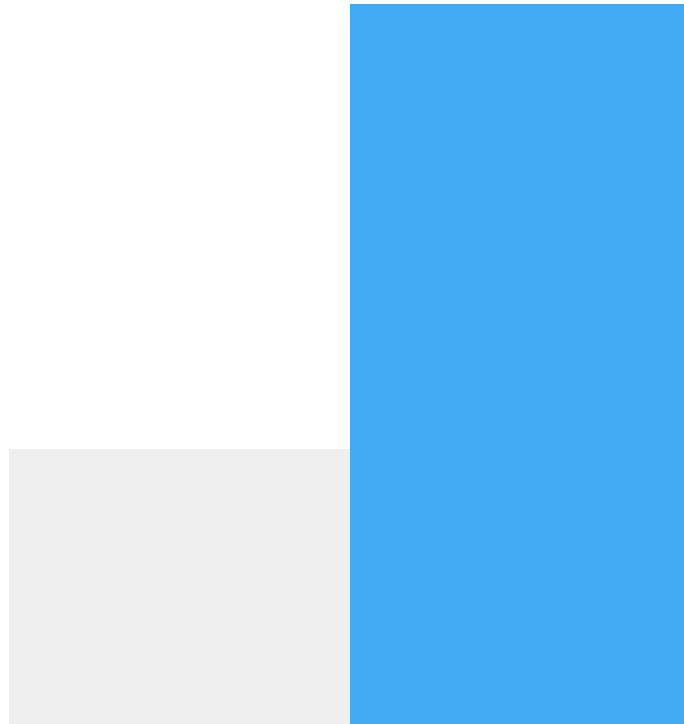
**Context:** Citizens with disabilities face difficulties in accessing digital public services independently, particularly in the areas of service search and online application submission.

## Requirements:

- **Accessibility:** The solution must incorporate speech to text conversion capabilities and AI technology to enable voice commands for accessing and navigating public services.
- **User-friendliness:** must be intuitive and easy to use for all citizens, including those with disabilities.
- **Interoperability:** The solution should integrate seamlessly with existing public administration websites and online service platforms.
- **Security & Privacy:** must adhere to data protection regulations and ensure the security and privacy of user data.

## Next steps



In GR-digiGOV-innoHUB, we consider public procurement as a major instrument by which government can encourage innovation in public administrations and the overall economy.

- ✓ We are planning to conduct at least one full PCP/PPI cycle, starting from public sector requirements validation (including prior-art analysis and IPR search)
- ✓ For each challenge identified, it is important to describe the problem to be solved by defining clear outcomes that are required (functionality / performance / efficiency improvements)
- ✓ Functional and performance evaluation between state-of-art and challenge technology requirements will determine type of Innovation Procurement (PCP or PPI), and its necessity.

# Preparatory Steps

Requirements validation for each challenge is recommended



A prior art analysis will be conducted to confirm whether the identified challenge (s) are indeed "unmet".

- ✓ If the prior art analysis reveals that there are already solutions available on the market that can meet the need, then there is no more need for an innovation procurement.

A preliminary IPR search is equally important

- ✓ verify how innovative is the R&D (for PCP) or the innovative solutions (for PPI) to be purchased
- ✓ reveal whether there are already market entities who own "key IPRs" that cannot be avoided to address the identified need(s), and if so, examine the licensing policy

Build the business case - Analysis of costs versus benefits of starting an innovation procurement

# Open Market Consultation

Widen awareness of the GovTech industry regarding the tender to be launched

Publish RFI requesting ideas and proposals for technical and R&D solutions/results (use of Marketplace solutions repository and matchmaking tool).

Collect comments and insights from the market which can be used to fine tune the tender specifications.

Organise events/meetings to cross check, elaborate and deliberate information on what is the state of art (e.g., for PCP : technologies available at TRL 4 or 5 that can be brought at TRL 8).

Involve experts (technical-legal) who can lead the discussions and interpret the results of the market consultation

# Execution of the procurement procedure for a PCP (or a PPI)

Develop the tender documentation (RFP, Technical annex, draft framework, and specific phase contracts) and an overall and appropriate strategy and structure to conduct the procurement activities during the execution of the project, and define the evaluation, validation strategy and assessment of the results achieved.

Call for Proposals (publication of the contract notice), proposals evaluation and selection of contractors, signature of framework agreements

## PCP Phases

1. Solution design,
2. Prototype development & evaluation,
3. Operational validation - original development & testing of a limited set of 'first' products or services

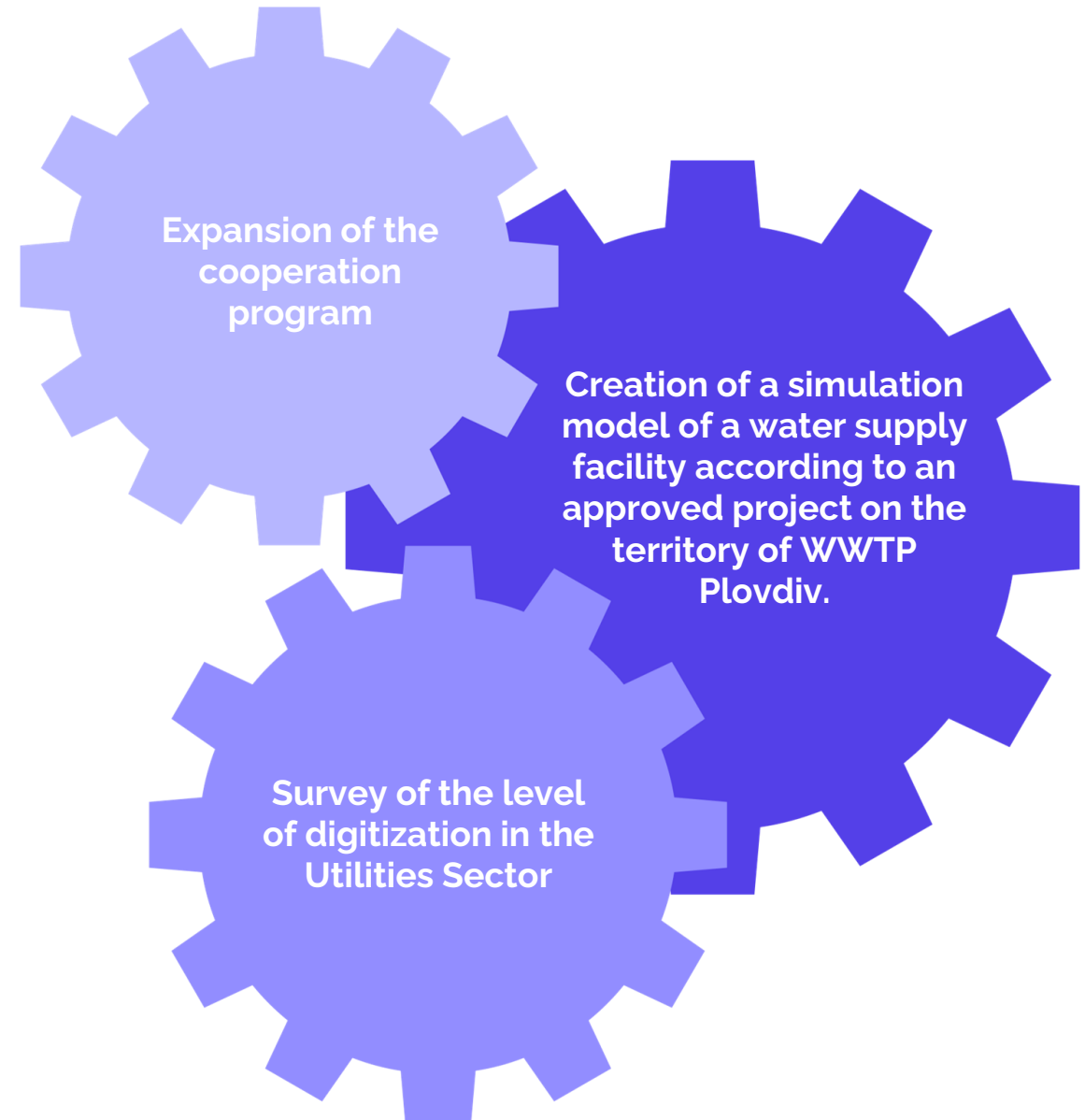




# What next?

Several of them are published on TED, but our benchmarking also identified that many innovation procurements that are not subject to EU publication requirements, are published only nationally (e.g. on national websites, portals).</p> <p>Still, we regularly scan TED for PCPs, and also through our network or contacts in Member States get alerts of calls for tenders and open market consultations. **The GR-digiGOV-innoHUB:** *How this Greek EDIH will help public sector organisations tackle challenges that require innovative digital solutions: plans for innovation procurement tenders.*

	Question	Answer
1.	You are planning to conduct market consultations in relation to your identified challenges. Will the Open Market Consultation be carried in Greek or English?	We will consider a preliminary market consultation in Greece to determine the ‘depth’ of the market there, followed by pan-European Open Market Consultation in English.
2.	How do you foresee the cooperation with other EDIHs?	<p>Although we are at different levels of development and ambition, we can exchange experiences and good practices regularly. It is important to be part of an EU network and learn from each other.</p> <p>It may also be possible to share resources, such as a “marketplace” platform for matchmaking demand with what’s available in the market. There are developments already existing in the organisations and EU associations which can be leveraged for the participation of SMEs and cross-border cooperation net.</p>

**Crowd in Motion EDIH:** *Insights in how this EDIH aims to match its initiatives with green public investments and innovation procurements*

	Question	Answer
1.	Are your challenges targeting solutions at higher TRL (products almost ready)?	We are open to various challenges or problems public organisations are facing. With the format of an IÖB-challenge we screen the market and help public organisations finding suitable





		solutions for their problems. The TRL varies. In most of the cases we receive solutions with higher TRL but we also had challenges where the best solution still needed to be developed. In this case an innovation partnership could be the right procurement procedure.
2.	How does the instrument of e-catalogue work for innovative solutions?	Companies who have been approved with their innovative solutions on our innovation platform (IÖB-Innovationsplattform) have the possibility to be integrated directly in the BBG e-catalogue for direct awarding. .
3.	How to cooperate with other EDIHs?	Sharing experiences and learning from each other is key to success. If a partner is stuck, it's important to use the network and reach out to others. Asking them if they have been in such a situation and then work together to solve it. Different organisations can have similar challenges and problems.
4.	Are the services offered also to non-Austrian parties?	The seminars and trainings are for public organisations and also for young companies so they can learn about tenders and procurement procedures. The target group and conditions to participate vary from event to event.

**UDIH 4 EU:** *Planned activities of this Bulgarian EDIH to stimulate innovation procurement in the*

	Question	Answer
1.	What kind of support would you like from your colleagues?	Learning from other experiences, in particular from the lessons learned from the EAFIP initiative.
2.	How can the EDIHs participate in defining the tender specifications?	EDIHs provide coaching services including their services related KPIs only, basically moderating between the stakeholders and their positions in digitalisation (and evidently attached to the business cases of the SMEs as a byproduct). EDIHs are not addressing the key business cases nor tender specifications of the service providers nor the SMEs.



## Discussion with EDIHs

Which innovation procurement related activities are EDIHs interested to develop? How can EDIHs cooperate with other EDIHs on innovation procurement? Do EDIHs see links with other initiatives?

### Some key comments:

- One of the roles of EDIHs is to connect the dots in digitalization. The SMEs should be informed about the possibilities of the tender specifications thematically. The thematic EDIH working groups can easily disseminate the like-minded tender specifications to the like-minded SMEs operating in the same sector.
- There is a request of information on new regulations toward Environmental Product Declaration (EPD) that SMEs can apply to.
- The state of play is different in each Member State, therefore cooperation is essential in aspects such as cybersecurity, standards, interoperability, etc. and explore the role of EDIH regarding the needs analysis from the demand side.
- SMES already working in a specific sector can bring solutions to from different sectors. For example, in Austria the challenges are published aiming that companies from different sectors can contribute. In one challenge for where a university hospital wanted a robotic solution for the kitchen, a company working in the waste sector provided an almost perfect solution to the hospital. It is important to open up the capacity of SMES for the benefit of public authorities,
- Leaving the Intellectual Property Rights vested in the contractors creates the opportunity to exploit the R&D results and commercialize solutions.
- Some Member States or regions are not used to innovation procurement, not only from the demand side but also on the supply side. One first step is to create trust in a Government to Business environment. Cultural aspects should be taken into account in this regard.
- In first-hand the service providers should make up their mind what they want to do. The companies and consultation help, but it is really the interest of the service providers to define the need themselves and not to be lobbied too much by the private sector companies.
- How to land to relevant tender specification is a complex process where EDIH might find their role. An obvious immediate role could be to share the available tender specifications.
